NHSA is engaging in a multi-year campaign to increase public understanding of Head Start’s effectiveness in driving successful outcomes for America’s most vulnerable children and families — also known as the “Head Start Advantage.” The first product to come out of this initiative is the new Head Start Language Playbook. This Playbook is intended to help Head Start staff, parents, and alumni have better, more effective conversations about our mission with the public. In this training, participants will learn how to use the tips in the Playbook better communicate the power of Head Start: who we are, what we do, and why it matters. Through interactive teaching methods such as role-playing, participants will also learn how to tailor their message to specific audiences, including elected officials/policymakers, k-12 school administrators, and anyone in general who may be skeptical about Head Start.</p>
